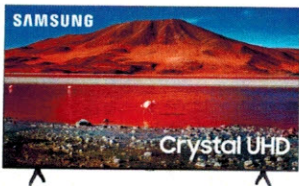

How to access the Benefits site

- Go to the Bell Benefits site bell.ca/mybenefits and click on the second bullet for the login page.
- Enter your Retiree ID and temporary password (Date of birth YYYYMMDD and the last 3 digits of your postal code). Ex: With date of December 25, 1960 and the postal code of H2B 3C4, the password is 196012253C4. Your retiree ID can be found on your last annual pension statement.
- Select Communication Preferences under the Quick links tab and provide electronic consent to receive communications by email.
- Once completed, you will receive an email confirmation and you will be eligible for the draw.

Please note: Emails will not contain personal information, but will alert you to when new personal documents, such as your annual pension statement, are available on the Benefits site.

Pension entitlement certification

As part of good governance, ensuring the integrity of pension payment management, Bell conducts annual retiree audits with pensioners. Beginning this year, Bell MTS retirees will be included in the annual audit. The purpose of the audit is to provide proof of life and to ensure pensioner records are up-to-date and accurate. In July, retirees selected for this annual audit will be invited to log into the online Pensioner Audit tool, available on the Benefits site login page.

Please note that if you participate in our Go green with Bell contest, we will waive your requirement to be selected for the 2021 pension audit.
